

TERMS & CONDITIONS

Trusted Bursaries (Pty) Ltd – School-Days®

1. THE COMPETITION

- 1.4 The Competition is not open to employees and their direct family members of the Promoter, including the employees and direct family members of their respective advertising and promotional agencies and distributors.

2. THE PRIZES
